
### 2002-2004 Membership Directory

### DTBA Hosts Successful Winter Conference This Past January

Over 200 buffalo producers and enthusiasts from around the region made their way to Rapid City, SD the last week in January to attend the Dakota Territory Buffalo Association's (DTBA) annual Winter Conference. The conference is held in conjunction with the Black Hills Buffalo Classic Show and Sale and the Black Hills Stock Show.

On Saturday, the conference got an early start with the annual meeting leading off the day's events. Testifying their commit-

ment to the association, members turned out in large numbers for the one day conference. Many new members made this their first association event. Non-members were welcomed to join in and many did just that. DTBA President, Scott Peterson. offered some opening remarks and addressed the large

crowd. Peterson led the audience through a brief overview of the association's activities the past year. Nominations for new directors were also taken at this time.

Due to the conflicting schedules with the National Bison Association (NBA) Winter Conference, NBA Executive Director Dave Carter faxed an overview of the NBA event, along with best wishes for a successful DTBA conference. The remarks were read to the audience and were appreciated by those in attendence. Carter went over some of the issues covered at the NBA conference, including the hot topic of meat inspection and other pend-

ing legislative issues. Targeted marketing was also another source of much discussion in Denver.

South Dakota State Veterinarian, Dr. Sam Holland, was next on the DTBA agenda. He gave a report and update on some of the diseases and issues facing the buffalo industry. One comment made by Holland, in light of the struggles the industry is currently facing, is that "the meat industry is mature. The buffalo industry is immature". Holland's comment more than summed up the

situation the industry is in right now.

Other topics that Holland touched on included: the TB testing requirements and perhaps relaxing them in the future for the state; Dealer/Liquidation statutes where Holland suggested that it would be wise to include buffalo in these regulations; field slaughter and federal inspection guidelines regarding it; interstate shipment of state inspected meat and the issue of including buffalo as an amenable species. Holland also shared information on Chronic Wasting Disease and then took time to answer questions from producers in the audience.

Dr. Daniel Farrington of Black Hills State University, Spearfish, SD, presented to the group his proposal for buffalo research to be conducted right in the heart of DTBA country. Farrington noted that a group of researchers has been working on a project to include buffalo research, especially DNA work. He asked the audience what they, as a buffalo community, would want to see the research group focus on. The group is working to obtain the necessary grants and funding to get the research project underway and they are open to suggestions about topics and programs producers think would offer valuable information. Farrington would like to keep the project centered either in Spearfish or Rapid City, so as to keep it in this region. We will have more information on this project in upcoming issues of The Buffalo Heard.

The next presentation was made by Stan Swanson of the Great Plains Buffalo Cooperative. Stan updated the group on the progress of the venture. The project is moving along rapidly and is expected to begin providing meat to contractors this month.

Tentatively, an equity drive is slated for March of

2002. (see related update)

Just prior to the lunch break, the final presentation of the morning session was devoted to the DTBA's Reality Based Carcass Class. Chairman. Sandy Limpert, and RC Western Meats owner, Bruce Anderson, explained about the class to those present. This year marked the second year for the carcass class and the first year for heifers to be entered. With \$5,000 at stake for each winner of the bull and heifer class, Anderson and Limpert again pulled out all the stops to make sure the class was fair and that the winning animals were truly the top ones. Never

before has any data been gathered on slaughter heifers, so participants results. Surprisingly, the top two heifers outdistanced the top bull by quite a margin!! Goes to show we have a lot to learn about feeding and growing out

those attending were eager to hear of the heifers. The afternoon

session featured guest speakers, Brad Beavers of Dakota Bison Meats; Angie Bachmeier of Big Sky Buffalo; Ed Eichten of Eichten's Hidden Acres and Dennis Tuel of Buffalo Pass Ranch. All these speakers were selected and asked to come to the conference to share their experience and insight into the marketing of buffalo meat. Each one gave a short presentation on their own operation, what works for them and any other information that they cared to share. Following the presentations, they formed a panel and answered questions from the audience. Who better to help producers market buffalo meat than other producers who are out there making it work. Many positive comments about the presentation were offered when the session concluded.

The election of the new DTBA officers then took place and the business meeting wrapped up. There were three positions open for election on the board. A handful of candidates were up for election by the membership and when the votes were tailied, Scott Peterson, Rick Knobe and Jerry Austin were the three new board members. Following a short board meeting, new officers for 2002 are: President, Scott Peterson, Belle Fourche, SD; Vice-President, Jacki Limpert, Buffalo, SD; Secretary/Treasurer, Jud Seaman, Rapid City, SD; and Directors, Steve Schmitz, Jefferson, SD; Rick Knobe, Sioux Falls, SD and Jerry Austin, Fairburn, SD.

While the meetings and presentations were underway on Saturday, the Black Hills Buffalo Classic judges were looking over the animals entered in the 2002 show and making their selections. The awards were presented that evening at the ban-


