## DTBA Hosts Successful Winter Conference This Past January

Nearly 200 buffalo producers and enthusiasts from around the region made their way to Rapid City, SD the last week in January to attend the Dakota Territory Buffalo Association's (DTBA) annual Winter Conference.

On Saturday, President Scott Peterson offered some opening remarks and addressed the crowd. Peterson led the audience through a brief overview of the association's activities the past year. Nominations for new directors were also taken.

South Dakota State Veterinarian, Dr. Sam Holland, gave a report and update on some of the diseases and issues facing the buffalo industry. One issue that is always on the top of the list in South Dakota is the position on field kill of buffalo. Holland noted that it is becoming more frequent in the state and without the benefit of enough staff to cover the inspection requirements, the state has allowed some veterinarians to become certified to carry out the necessary field kill inspections. In that same line of thought, Holland noted that producers should be aware of the criticism that is out there regarding buffalo hunts. He noted that some individuals and groups consider the hunts to be inhumane treatment and it will be a matter of when, not if, the matter will be brought to the public's attention. He cautioned producers to stay informed on these issues so they can be prepared to deal with them when the time comes.

Holland touched on the Country of Origin Labeling issue, again noting that it will be mandatory in just a couple of years. He also told the group that label claims are becoming a big issue and certification of those claims is something they need to be aware of. "Affidavits and recordkeeping are very important when it comes to the label claims," Holland told the group.

As far as diseases are concerned, one issue to be on top of is that of roping steers. They are a substantial carrier of tuberculosis and Holland warned the crowd that if they have contact with these animals it would be wise to keep them separate from buffalo and from cattle, due to the substantial risk of spreading TB between the animals. He also spoke about West Nile Virus and the importance of vaccinating horses for the disease. Anthrax was present in the state this year, thanks largely to the hot and humid weather the state experienced this past summer. It was present in the western half of the state for the first time in many years and Holland cautioned that producers should be aware of the threat, especially when going into a dry area. Chronic Wasting Disease is another hot topic in the disease arena, but Holland said the consensus is the disease is limited to cervids such as deer and elk and there does not, at this time, appear to be any threat to other species from this disease.

Upon completion of his presentation, Dr. Holland was asked to stay at the podium and Peterson then announced that the DTBA was awarding the Pioneer Award to Dr. Holland for his outstanding service to the buffalo industry and to buffalo producers, both in and out of South Dakota. Dr. Holland has been a watchdog for the industry and the DTBA and has worked diligently for many years to ensure the buffalo industry has a level playing field with other livestock entities.

Steve Noyes, Deputy State Statistician for South Dakota, made a presentation to the group about the 2002 Census of Agriculture. Noyes went through the process of filling out the census and then explained to the group what the information can and will be used for and the importance of participation. The 2002 census will be the first time that buffalo have been included, so the importance of getting accurate numbers is critical and the data could be crucial to our industry as it continues to grow

and receive more recognition in the marketplace. Census information can be used to garner funding money and also to increase the visibility and status of various groups.

Merle Maass, president of the National Bison Association (NBA) Board of Directors, addressed the DTBA group and also touched on many of the benefits of joining the NBA and also briefly outlined the focus and plans for the NBA in the coming months. He noted that the focus of the NBA has shifted the past year and a half.

The final presentation of the morning was entertaining and active, to say the least. Gail Griffin, NBA state and regional liaison and also executive director for the Minnesota Buffalo Association, took the group through a presentation that not only stressed the importance of supporting both national and regional associations, but also about stepping up to the plate and helping those organizations achieve their goals. Griffin is widely recognized for her devotion to the buffalo industry and was recently named the NBA's Member of the Year. Her presentation brought out lots of laughter and gave those in the audience some food for thought. Participants in her presentation got a little taste of "thinking on your feet"!

Following the lunch break, NBA Executive Director, Dave Carter, addressed the group. Carter went through a timeline of the past year and a half, beginning with his coming on board as the executive director and where the NBA has gone from there. He reviewed the two marketing summits that have been held to date and then went through the various projects the NBA is working on, including meat inspection, Section 32, animal identification and a meat classification system. Carter also walked the audience through the NBA's new "Buffalo Stampede" campaign that will take place in Nashville, TN this spring. The NBA is working on a variety of projects, but as Carter noted, they all center on one theme...meat production. Carter also urged cooperation between the state and regionals and also asked for member support to help ensure the success all the NBA projects.

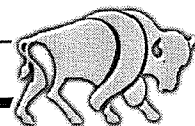
The highlight of the day's events was a carcass cut out demonstration presented by Jim Ferguson of the Saskatchewan Meat Processors and Larry Erber from the Saskatchewan Institute of Applied Science and Technology. These gentlemen first presented this demonstration in Regina, Saskatchewan this fall at the Canadian Bison Association meeting and agreed to attend the DTBA conference to do a similar presentation. DTBA organizers felt this tied in perfectly with the group's Reality Based Carcass Class and also carried forward the meat production theme that is running full steam in the business. Assisting in the demonstration were Bruce Anderson, owner of Western Buffalo Company in Rapid City and Al Holzer, the plant manager at Western Buffalo Company.

The election of the new DTBA officers then took place and the business meeting wrapped up. There were two positions open for election on the board. Jacki Limpert will continue in her role on the board and the new member will be Lorene Bender. Following a short board meeting, new officers for 2003 are: President, Scott Peterson, Belle Fourche, SD; Vice-President, Jud Seaman, Rapid City, SD; Secretary/Treasurer, Jacki Limpert, Buffalo, SD; and Directors, Steve Schmitz, Jefferson, SD; Rick Knobe, Sioux Falls, SD and Lorene Bender, Britton, SD.

During the evening festivities, the group played Bison Bingo. Shawna Stevens won the feeder donated by Doug Woodall, Hi-Hog Equipment and Rob Trynoski won the buffalo print donated by the DTBA.



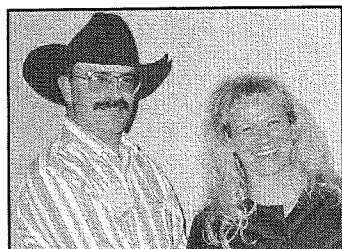

## Feed Assistance Available

DENVER: The head of the National Bison Association recently hailed the U.S. Department of Agriculture Feed Assistance program as "much needed help for ranchers attempting to survive the impact of the ongoing drought."

On Tuesday, April 8, the U.S. Department of Agriculture announced that it was releasing stocks of government-held non-fat dry milk to be used for blending in feed that could be purchased by producers of several species of livestock, including buffalo. The mixing in of the non-fat dry milk no longer fit for human consumption can help lower the cost of the feed purchased by livestock producers.

Dave Carter, executive director of the Denver-based National Bison Association, noted that the new program will help producers who have been forced to bear the cost of purchasing feed because of drought-stunted pastures.

"Buffalo producers rely heavily upon natural grazing land to provide the nutrients needed for their animals. Because of the drought, many of those ranchers have been required to purchase feed to sustain their herds. The expense of the feed costs is driving many ranchers out of business, and is threatening the stability of the overall buffalo business.

"We are pleased that the U.S. Department of Agriculture recognizes the difficulties faced by our producers, and is taking steps to help alleviate the problem."

Last fall, the National Bison Association had criticized the USDA for announcing a similar program, but limiting participation only to cattle producers. This week's announcement included producers of cattle, buffalo, sheep and goats.

The new program is targeted specifically for producers in designated drought-stricken areas. The non-fat dry milk is mixed with feed and supplements for the livestock.

Producers wanting more information regarding eligibility for the program can contact their local USDA Service Center office.

Previous Throlson scholarship recipients are ineligible.

The air at Riverside Park will be filled with smells from the past this summer.

A Dutch Oven Cook-off will be held Saturday, Aug. 23, in conjunction with the Yankton Lewis and Clark Festival. This is the first year for this event, and Yankton Lewis and Clark Bicentennial, Inc., member Diane Norton has high hopes for its success.

After last year's festival, Norton said she went on the Internet looking for a new addition. She chose this event because the Yankton area is where Lewis and Clark talk about the immense herds of buffalo.

**In her research, Norton came in contact with the Dakota Territory Buffalo Association in Rapid City who loved the idea of the cook-off. They are providing the grand prize of a buffalo robe and an honorable mention award of a buffalo skull.** Other awards include an honorable mention gift of Lewis and Clark commemorative Dutch oven cooking utensils. The People's Choice winner will receive Lewis and Clark Bicentennial apparel.

Norton also came across the International Dutch Oven Society (IDOS). Through her communication with this group Norton was able to make Yankton's cook-off a sanctioned event.

The fact the event is sanctioned is helping it gain nationwide attention. The winner of the Yankton cook-off will be eligible to participate in the International Championship Dutch Oven Cook-off in Utah.

"Being it's a internationally sanctioned event, it will draw participants from outside our region. Not only will this help boost attendance at the festival, it will also help tourism in general in the area," said Lewis and Clark Bicentennial Inc. president Heidi Henson. "It may also keep people here longer than just that weekend."

Norton said she is already receiving numerous calls about the cook-off from across the country.

"We've had a lot of inquiries so far and they are coming in from Tennessee, Utah, Kansas and a group out of Montana," she said.

One condition of being a sanctioned event is that the contest **must be a three-pot cook-off. These three pots must include a main dish with bison meat, a dessert and a sourdough raised bread.**

## Minutes of the April 5, 2003 Board Meeting - Video Conference

Members present at the Southeast Technical Institute in Sioux Falls were Rick Knobe, Steve Schmitz and Lorene Bender. Members present at the Belle Fourche Middle School in Belle Fourche were Scott Peterson, Jacki Limpert and Karen Conley.

President Scott Peterson called the meeting to order.

Minutes from the January 31, 2003 board meeting and the February 1, 2003 general membership meeting were presented by Secretary, Jacki Limpert. Steve Schmitz moved to approve the minutes and Rick Knobe seconded the motion. Motion carried.

Limpert discussed the treasurer's report. Board members decided to have quarterly reports available. Knobe moved to approve the motion and Bender seconded. Motion carried.

The Membership Directory was discussed and Conley gave an update on the project. Bender had previously suggested adding restaurants listings to the directory, but it was decided it would take too long and might not have the results we were looking for at this time. Discussion of the restaurant listings and Buffalo Chips idea will be discussed at a later meeting. Conley will have our two year membership directory printed and distributed in May 2003.

Julie Brewer and Amy Rank, our winter conference contacts at the Rushmore Plaza Holiday Inn, presented the board with a contract for our 2004 winter conference. Discussion took place and Limpert will sign the contract as soon as the revisions are made, as directed by the board.

Discussion was held on how the Black Hills Buffalo Classic went, problems that were encountered and how to address them. Speakers for the 2004 winter conference were discussed and a theme for the event was brought up. A decision was made that during our summer board meeting, we would open the floor and spend some time discussing the show and sale. Member input will be encouraged on this issue.

The board talked about offering booth space to vendors during our winter conference. Schmitz made the motion that the DTBA would allow six booth spaces to be rented under the following conditions: The renter must be a DTBA member or non-profit in our industry; booth space would include a six foot table in an approximately six by eight space. The vendor will be required to purchase one full conference registration and pay a \$50 booth fee. Applications will be sent to the DTBA office prior to the winter conference and vendors who qualify will be allotted space on a first come, first serve basis. Knobe seconded the motion. Motion carried.

It was decided that there will be no Summer Conference this year due to lack of response. The next meeting will be a Board of Directors meeting, open to all DTBA members, on Saturday, July 26. The meeting location is tentatively scheduled for Chamberlain, SD.

The board decided to operate the DTBA trade show booth at the 2004 Black Hills Stock Show.

The association web page was discussed. Knobe and Conley have looked at several options and have decided to go with Bob Linder from DigiSage. He does the Minnesota and Iowa web pages. There is a \$50 per month server fee and it will take four to six weeks to get the site built and on the web. There was a discussion about financing the site and how much to spend to get it up and running. Knobe made the motion to spend up to \$3,000 to build the web site. Bender seconded. Motion carried. The site will be a top priority to get done and Bender suggested when it is that we should link into [www.sdtravel.com](http://www.sdtravel.com). Conley will make payment arrangements with the company.

At our winter conference this year, the membership elected to do another series of billboards for our association. Schmitz talked with Avery Brothers and we will have two billboards, a 10 x 32 at milemarker 14 on I-29 in the northbound lane. There will be a 10 x 40 sign on I-90 at the Alexandria exit. The contract is for 18 months and the billboard should be up in April or May. There will be an art charge of approximately \$1,200, as the design has been changed somewhat. The monthly fee will be \$450 for both sites. At our winter meeting, twelve members agreed to sponsor the sign for one month each and Conley will go ahead and send out invoices to those members. We will continue to try and solicit funding for the remaining contract months.

Knobe has agreed to be the chairperson for the DakotaFest event that will be held in August in Mitchell, SD on August 19 - 21. We will again be doing a food vendor booth. Knobe would like to have a meeting in May with anyone interested in helping with this event.

The Lewis and Clark Festival will be held in Yankton, SD on Saturday, August 23. We will have a booth at the event and we are sponsoring the grand prize and a runner up prize for the Great Plains Bison-Centennial Dutch Oven Cook Off. In return for our sponsorship, we are listed as a major sponsor and their web site is linked to ours and there will be no charge for our booth space. Conley will be present at both DakotaFest and the Lewis and Clark event.

A discussion was held on fundraising activities. The buffalo leather chair raffle was a hit, with the association making just over \$1,500 in under three months. The idea to hold another raffle was discussed. The association has a Sharps rifle available, #20 in a limited edition series that was commissioned a number of years ago. The association has the artist's proof in its possession and it will be kept in Peterson's locked gun cabinet until we decide what to do with it. Conley and Seaman will check into getting the #20 gun manufactured and we would like to raffle it off, starting as soon as possible. Knobe motioned to sell tickets for the #20 gun, one for \$5 or 5 for \$20. Bender seconded the motion. Motion carried. Peterson will get the artist proof gun appraised and get insurance on it. We will add this asset to our balance sheet.

There was also discussion on other items to raffle or offer for sale at our trade show booths. Conley indicated that she has lots of interest in hair on hides. The board will do some research on this subject and discuss at the next board meeting.

Conley asked the board for input and deadlines on the newsletter. It has always been done on an as needed basis. The membership indicated that communication needs to be better, so it was decided that newsletters will go out quarterly with other issues as needed (conference, etc.). Newsletters will be printed and mailed by March 1, June 1, Sept. 1 and Dec. 1. We will also look at offering advertising in the newsletter. Conley will work on pricing information and bring suggestions to the next board meeting. Knobe made the motion, Peterson seconded. Motion carried. Conley will get a newsletter put together and mailed as soon as possible for the March issue and then we will follow the schedule as set by the board.

The board decided to discuss the Executive Director position at the summer meeting.

Bender discussed her idea for a "Buffalo Chips" promotion, similar to the "Beef Bucks" promotion done by the Cattleman's Association. There was also discussion about offering educational materials to restaurants with the association doing this two or three times per year. Look into grants or sponsorships to cover the costs. Bender and Conley will work on getting pricing information on various materials and present information at the summer meeting.

The board decided to publish minutes of their meetings in the newsletters in an effort to keep the members better informed. Peterson explained that the video conference would cost \$30 per hour on each end (Belle Fourche and Sioux Falls). Our meeting lasted three hours for a cost of \$180. Peterson asked who should pay for the cost, the DTBA or the members. The board members elected to split the cost among themselves so there will be no cost to the association.

The final topic was the North Dakota Buffalo Association. Peterson asked if anyone else had heard or talked to any NDDBA board members about possibly working together on projects for the benefits of both memberships. No one had heard anything. Peterson will draft a letter to the NDDBA offering to explore the possibilities.

Motion to adjourn the meeting was made by Bender and seconded by Knobe. Meeting adjourned.
