The Plains, Trains and Tatanka Wagon Train and Horseback Ride will be the kickoff event for the IBC 2007. The dates for the wagon train are July 20 through July 24. Although this is an additional cost, optional event, interest is very high for the 150 available spots. Applications for the event have been mailed out to all current buffalo/bison association members and are also available online at www.ibc2007.com and www.bisoncentral.com. Details and information about the wagon train are included with the application packet. There are still spots available for this once-ina-lifetime event, so get your applications forms in today!

On Tuesday, July 24, the opening ceremonies of the 2007 IBC will take place in the late afternoon/early evening at Mt. Rushmore National Memorial. For those that have never seen the "Shrine of Democracy", you'll be in for a real treat. There will be a private reception with a keynote speaker out on the terrace and then we'll join the general public for the nightly lighting ceremony where the four faces will be illuminated in the evening

sky. Selecting this location for our opening night was a natural. Mt. Rushmore is synonymous with South Dakota and is an integral part of western South Dakota's landscape.

The National Bison Association and the Canadian Bison Association are working diligently to line up a slate of speakers and presenters with informative and timely topics that will be of interest to all bison enthusiasts.

The afternoon and evenings will be full of fun and entertainment for everyone. On Wednesday, some participants will want to attend the optional Foundation Supper at Crazy Horse Monument, while others might opt for a chuckwagon supper and cowboy entertainment. Still others might choose to strike out on their own and explore the area and the many fine offerings of food and fun. Thursday afternoon and evening, our activities will focus on downtown Rapid City. The IBC committee is working to put together what we might term a festival of sorts, with music, food, shopping and the like. National Bison Association Issues Action Alert For Drought Relief

Press Release from the National Bison Association

Westminster, Colorado (November 13, 2006) Lawmakers heading back to Washington, D.C. to wrap up the unfinished business for the 2006 session are being urged by the National Bison Association to assure that the pending drought assistance package include language assuring that buffalo ranchers will be eligible for aid.

In a letter to U.S. Sen. Kent Conrad (D-ND) and all of the co-sponsors of the Emergency Farm Relief Act of 2006, National Bison Association Executive Director Dave Carter wrote, "Bison ranches across the country are facing the same devastating weather-related conditions as cattle ranchers. Like their neighbors in the cattle business, our members have been forced to purchase expensive hay and forage to make up for the lack of adequate grass."

"We are compelled to write this letter because the U.S. Department of Agriculture implemented the recent Livestock Assistance Grant Program in a manner that allowed State Departments of Agriculture to discriminate against the bison industry," Carter added. "In South Dakota, Texas and Minnesota, for example, bison ranchers were deemed ineligible to apply for any Livestock Assistance Grant Program funding."

Congress is scheduled to consider final passage of a \$4.9 billion disaster assistance package when it returns for its lame duck session this week. The legislation contains provisions that allow livestock producers to obtain compensation for drought related livestock losses in 2005 and 2006. The legislation, however, does not define livestock.

Carter noted that the bison industry is just emerging to profitability after suffering four years of disastrous prices from 1999 through 2003.

"Unlike their neighbors in the cattle business, our members are already digging out of several years of record low prices for their animals. Consequently, bison producers' financial reserves were already depleted before this drought settled in," Carter wrote.

In addition to directly contacting the prime sponsors of the emergency legislation, the NBA issued an action alert to its membership urging ranchers to contact their members of congress on the issue.



Meeting Minutes From The Board of Directors


Board Meeting Minutes for the Dakota Territory Buffalo Assn. Board Meeting May 22, 2006 • Telephone Conference

President Jud Seaman called the meeting to order. Also present were board members Chad Kremer, Bruce Anderson, Mimi Hillenbrand and executive director, Karen Conley. Board member Steve Schmitz joined the meeting in progress. National Bison Association Regional Director, Scott Peterson, was also present for a portion of the meeting.

President Seaman asked for a motion to approve the minutes of the January 27 meeting. Hillenbrand made a motion to approve the minutes as read. Anderson seconded the motion. Motion carried.

President Seaman then asked Conley and Anderson to review the financial report that was emailed to all directors earlier. There were no questions regarding the report and President Seaman asked the other board members their opinion on taking funds from our savings account and putting them into our Piper Jaffray money market account. All agreed it would be a good move. President Seaman directed Anderson to transfer \$15,000 from the savings to checking account and to then take those funds and reinvest in the Piper Jaffray account. Conley will have the accountant cut a check for that amount once Anderson has transferred the money.

Peterson noted that the IBC account will be established in the next month and once it is operating and has funds available, Conley should do the paperwork to have the IBC reimburse the DTBA for monies spent on behalf of the IBC up to this point. From that time forward, the IBC account should be able to pay its own bills and deposits as needed.



There was no other business regarding the financials at this time. Kremer made a motion to accept the treasurer's report as shown. Hillenbrand seconded the motion. Motion carried.

President Seaman then referred the board to the issue of the Running of the Bulls in Deadwood in July of 2007. Information about this proposal was sent via email to all directors and President Seaman briefly explained about the situation. Peterson then spoke on behalf of the NBA and their position on this issue, which was to not endorse it due to the conflicting times with the IBC event and the risk factors involved. There was much discussion about the event and all directors voiced their opinions. President Seaman then told Peterson that the consensus of the DTBA was to not support the event as presented. Peterson will be taking that information back to the NBA and they will also formulate and issue a position about the proposal. Seaman, Kremer and Peterson all indicated that they would be attending the meeting in Deadwood regarding this issue.

Peterson then went on to update the DTBA board on the IBC event. IBC 2007, a non-profit corporation, has applied for a tax ID number and will be using Pummel and Associates in Belle Fourche to do the accounting for the corporation. Banking will be done through Wells Fargo Banks. During a recent NBA board meeting, Peterson said a review of the IBC 2000 event noted that the hosting party should receive some compensation for the work done to put on an event of this size. The NBA board voted to give the DTBA ten percent of the monies off the top before being split proportionately between the NBA and CBA.

Peterson also reported that the National Buffalo Foundation will be giving the IBC a \$10,000 grant to help fund the event. The CBA also has grant monies that are earmarked for the IBC.

Peterson asked for any questions regarding the Running of the Bulls or the IBC event and being there were none, he exited the meeting at that time.

Conley noted that she is receiving feedback postcards from the Winter Conference. In the near future, she will compile the answers from all the postcards and forward that information to the board for review.

The trophies for the 2007 event are not secured at this time. President Seaman will continue to try and contact Tony Chytka to see if he is interested in designing a new bronze for us to use and to figure up a cost for any new trophies. The board would like to see a meeting with Chytka and the DTBA representative set up by June 1 so information can be shared and decisions made by the next meeting.

Discussion on the 2006 Summer Meeting and Ranch Tours was tabled due to Tom LeFaive not being present for the meeting. Conley will contact him and request that information be sent to her by June 1 so that she can forward to the other directors for review and plans can be finalized.

Conley asked for clarification on the December St. Onge buffalo auction. President Seaman indicated he will talk with Scott Peterson to see what needs to be done on this auction. Anderson volunteered to do what he could and Hillenbrand volunteered herself and Dave Schroth to help with animals in the yards. All agreed that due to lack of interest/response, an auction in the eastern half of the state would not be pursued at this time.

Conley reviewed a number of requests for meat donations or reduced price meat supplies and/or participation requests. It was agreed to sponsor a buffalo meat meal for the National 4-H Shooting Sports Foundation meet in Rapid City the end of June. Anderson estimated a cost of \$750 to \$800 with the numbers proposed. He felt the donation should be capped at \$1,000. DTBA will pay for \$500 of the cost and Western Buffalo Company will pick up the remaining cost on this sponsorship. Participants from

around the country will be in attendance and for many, this will be their first time to sample buffalo meat. Kremer made a motion to approve the meat donation as outlined. Hillenbrand seconded the motion. Motion carried.

The association insurance policy was discussed. Conley is not comfortable with some of the wording regarding our show and sale and feels we need to address this issue in person with Black Hills Agency representatives so we are all on the same page before the 2007 event. President Seaman asked that she provide copies of the current policy to all board members to review. We will discuss this at the next meeting and then, if needed, set up a meeting with the insurance agents to review our policy.

The Membership Directory will be produced this fall. Good response so far. Same size and style as the previous one. Production to begin in August with a completion date of October 1 to begin distribution this fall.


The National Buffalo Museum in Jamestown is in need of additional funding to help with building projects such as new windows. DTBA has been very supportive each year of this cause and Anderson made a motion to send a \$2,000 check to the museum to be used for building improvements. Schmitz seconded the motion. Motion carried.

The topic of New Producer Seminars was discussed. All agreed that we need to revive these seminars as a way to bring new people into our industry and offer our assistance to them when they are starting out. The board would like to try and hold one in conjunction with the November live animal auction at

Custer State Park. Partnering with Bradeen Auctions on Friday night to incorporate a seminar was discussed as well as Friday during the day at the buffalo corrals or early Saturday morning at the corrals. Hillenbrand also offered the 777 Ranch for tours, as it is located near the park. It was also decided to put on a formal seminar the Saturday morning of the St. Onge auction. One was scheduled for this past year, but no plans were finalized in time to get this done. The board will begin working on putting together a minimum of two New Producer Seminars before the end of the year.

Conley asked for input and discussion about the financial situation, specifically the need for two signatures on petty cash checks. This becomes a problem when officers are spread out across the state. The bank has our account set up for two signatures on anything that is cashed. Conley would like to have it be one signature, as checks can only be cashed (with current wording) for up to \$500 at this time. Anderson made a motion that checks to be cashed over \$2,000 require two signatures but under that amount only one signature would be required. Kremer seconded the motion. Motion carried. Conley will check with the bank to make sure we can implement this procedure and get back to the directors with a final answer. If it can, she will provide the necessary paperwork and officer signatures to the bank to implement this change.

There being no further business, Anderson made a motion to adjourn the meeting. Kremer seconded the motion. Motion carried. The next meeting is tentatively scheduled to take place during the summer meeting at a time and location to be determined.

You do not have to be a member of the Dakota Territory Buffalo Assn. to consign animals to this auction.

1. Each buffalo must be listed on the health papers along with their corresponding metal ID tag (unless they are females under 12 months of age) and consignor's ranch dangle tag. All other tags must be removed from the animal.

2. Bangs tested or vaccinate

a. All female animals over 12 months of age must be tested

b. Heifer calves 4-12 months can be vaccinated or tested. (Non tested or non-vaccinated can't go to Mont. or Wyo.).

3. Slaughter cows do not have to be Bangs or TB tested. Slaughter cows will be sold last.

4. If females are preg checked, it must be noted on the health papers.

5. Females are sold as open or preg checked only. No such thing as pasture exposed.

6. Commission fee is 6% on all buffalo. No sales are 6% of the last bid. St. Onge Livestock will charge and additional \$15 per head yardage fee on all buffalo still there past Sunday noon.

7. All buffalo must be at the sale barn by 9:00 a.m. on Saturday December 2, 2006.8. Buffalo must be in saleable condition. Buffalo are sold as is and any guarantee is between the buyer and seller.

9. All animals will be insured on day of sale for \$.08 per \$100.

10. Please make every effort to sort animals before delivering them to the sale barn.

11. Make sure your vet reads these rules. If your animals do not meet these rules they will not be unloaded.

HEALTH REQUIREMENTS

- 1. Negative Tuberculosis test (caudal fold) on all animals. Test must have been done within 25 days of sale date.
- 2. Negative Brucellosis test on all animals. Test must have been done within 25 days of sale date.
- 3. Negative Anaplasmosis test on all animals. Test must have been done within 25 days of sale
- **4.** All females MUST be calfhood vaccinated for Brucellosis. Show tag numbers, metal tag numbers and BV tattoo numbers must correctly coincide on the Health Certificate.
- **5.** All animals must be treated with INJECTABLE ivermec. *IMPORTANT*: Animals coming from south of the southern Wyoming-Nebraska-lowa borders must be injected within 10 days of the show date. Animals coming from north of these southern borders must be injected within 25 days of the show date.
- **6.** ALL yearling bulls MUST be semen checked and certified fertile. *IMPORTANT!* Yearling buffalo bulls mature later than beef bulls and are often harder to test. Make sure your veterinarian knows this!
- 7. All two year old heifers must be certified at least 90 days pregnant.
- 8. All yearling heifers must be certified OPEN.
- 9. PLEASE NOTE! A consignor bringing in two year old bred heifers will be required to have a Teeth Affidavit Form filled out and signed by their veterinarian indicating that the veterinarian checked the animal between November 29, 2006 and January 25, 2007 and the animal had only two adult teeth at the time of inspection. Two year old animals who arrive at the show grounds and do not have a completed Teeth Affidavit Form will not be unloaded and the consignor will forfeit any entry fees for those animals. A National Bison Assn. tooth chart is included in this entry packet for your reference and a Teeth Affidavit form is also included. Any two year old animal that has four or more fully erupted teeth will be immediately disqualified and the consignor will forfeit any entry fees.
- 10. Three copies must be furnished with the original health certificate. Separate health certificates are required for each animal. Pens of three can be on one certificate with three copies.
- 11. Animals WILL NOT be unloaded if the health certificates do not meet ALL of the above requirements. NO EXCEPTIONS! Pregnancy test, semen test, ivermec and mouthing must be written across the bottom of each health certificate with the date and signature of your veterinarian. Keep your test paperwork with you in case it is needed.
- **12.** Any animal entered in the Black Hills Buffalo Classic Show and Sale can not have entered another show and sale in the six months prior to the Black Hills Buffalo Classic event.

Dehorned animals accepted are yearling and two year old heifers ONLY. All others must have either two good horns or broken horns which have fully healed. We will work with you in case of a broken horn while at the show. Severe bleeders cannot enter the sale ring.

EAR TAGS

Show tags, NBA Source Verification tags, metal vaccine/tag and registration button are the only tags accepted to be in the buffalo's ear. Consignors will be responsible for applying the show tags in the LEFT ear. This must be done before the animals will be allowed to unload. Any animal that shows up with an extra tag will be charged \$50 to take the tag out.

CARCASS CLASS ENTRY INFORMATION AND TERMS

- 1. Entry fee is \$300 per consignment. One entry per consignor in each class. ENTRIES MAY NOT BE POSTMARKED BEFORE NOVEMBER 15. ENTRIES POSTMARKED BEFORE NOVEMBER 15 WILL NOT BE ACCEPTED. Consignors will be notified by December 8 if their entries are drawn for the contest.
- 2. All entries will be mouthed when they arrive at Western Buffalo Company on the slaughter date. On that date, only bulls with all their baby teeth will be accepted and heifers can not have more than two permanent teeth.
- 3. PLEASE NOTE: In keeping with the reality-based theme of this contest, the DTBA Board of Directors has implemented new weight minimums on animals entering this contest. The minimum weight for bull carcasses will be 550 pounds. The minimum weight for heifer carcasses will be 435 pounds. Please keep this in mind as you select animals to bring to the contest. Carcasses not meeting the minimum weight requirements will be disqualified from the contest and there will be no entry fee refund. Western Buffalo Company has agreed to purches those carcasses at an approximate price of \$1.85 for bulls and \$1.75 for heifers, depending on the market, or the consignor may pay the processing fee and take the meat home. All other terms and conditions relating to the carcasses will still apply to those that are disqualified from the contest.
- 4. No health papers are needed on the animals participating in the Carcass Class.
- 5. Bulls and heifers will be delivered live to Western Buffalo Company in Rapid City, SD on Monday, January 8, 2007 only. Please be aware that, given the work schedule at Western Buffalo Company, the association is trying to work within a set time frame. We will be able to process all entries in one day.
- 6. South Dakota State University and a State Inspector will be on hand to oversee the testing of the meat cuts. All cuts will be trimmed to 1/4" fat cover and the ground buffalo will be tested for fat content and a sliding scale for value of product will be set up.
- 7. All buffalo will be boxed separately and frozen. Cut test sheets on each carcass will be developed showing how the cuts or group of cuts affect the bottom line.
- 8. The winner of the Carcass Class will be the buffalo that yields the most percentage of profit.
- 9. The winning carcasses will become the property of the Dakota Territory Buffalo Association and will be purcahsed by Western Buffalo Company with the proceeds going to the association.
- 10. The ribeye from ALL carcass class entries is donated and will be used as the main entree at the DTBA Awards Banquet during our Winter Conference. The cost of the ribeyes from ALL the entries is put into one lump sum and then equally deducted from each consignor's check. If you want the meat back from your animals, be aware that the ribeye area will not be included. There will be NO EXCEPTIONS!
- 11. All other entries will have the option of paying a modest processing fee and taking their carcass home or Western Buffalo Company will purchase the carcass s outlined above.
- 12. Consignors will be asked to provide a history of entries, to include items such as days on feed, type of feed, genetics, weaning weight, last available weight at home, etc. Please keep this in mind as you prepare your entries. All entries will be photographed at Western Buffalo Company prior to slaughter.
- 13. Class winners will receive points that go toward the BHBC Producer of the Year award.
